002 Ref. RAP14.097 - Rally Car Registration Scheme
Panel noted that with the Qld election having been called and the Government in caretaker mode, there cannot be an outcome until a new Government is sworn-in and TMR can progress the MOU with CAMS. Panel Chair will continue to get updates from CAMS.

Update provided on final numbers which are expected to exceed 75. All other planning and action are finalised. Panel members thanked Peta Davies for her excellent work on the Dinner planning. (Postscript: The Dinner was a great success at a good venue and well attended by CQMSC members)
- 004 Ref. RAP14.100 - 2015 QRC Series Sponsorship
Panel noted that Hankook Tyre will not be a partner in 2015. Further approaches are to be made to prospective partners.
- 005 Date Change QRC1
Discussion occurred on the decision of QSC to change the date of QRC 1 and the impacts on QRC 2 at Wowan. Panel Chair noted that better interaction with the Panel by email etc. should have occurred even though the timeframe was short.
