##### MINUTES OF PREVIOUS MEETING:

- 026 The minutes from the previous meeting held on 1 April 2015 were accepted as a true and accurate record.
- 027 There were no Minutes from the May meeting but QSC ratified QRC 5 to be run by BSCC at Jimna on the same date as the cancelled Kyogle Rally.

##### BUSINESS ARISING FROM PREVIOUS MINUTES:

- 028 Ref. RAP15.020 - Rally Car Registration Scheme  
An update was given on the roll out of Rally Vehicle Registration Scheme in Queensland.

- 029 Ref. RAP15.025 - QRC2 at Wowan  
Clay Weston gave a report on QRC 2 Wowan Rally which was a sporting success. Financials are being finalised. The closeness to QRC 1 was considered to have an effect on entries.
- 030 Chair gave an update on the preparations and entries received to date for IROQ QRC 3 and 4.
- 031 Panel considered a proposal from Richard Opie (NSW) to have the Rally of New England at Glen Innes included in the 2016 QRC Calendar in the April period. After some discussion, Panel voted against this proposal. Chair has advised the NSW Rally Panel and Club.
- 032 Jamie Lawson presented a paper on a proposed Clubman and Junior Championship or Series in 2016. It was agreed that further work be done on this concept and that it be under the “umbrella” of the QRC but used as an “entry level” competition. It would consist of Multi-Club events or Short Course Rallies.
- 033 Panel considered an email from Justin Northage which reported on the social media and on event media at QRC 1 and QRC 2. Panel agreed that it should support the efforts of people doing these activities but will not be able to provide financial support to purchase equipment or cover travel costs.
